## 7. Odds

- Should we increase the student rate? No – we only have a handful of students so raising the rates won't change our budget and will have a detrimental effect on students joining AGS.
- Advertizing rates have not been changed for over 15 years. Current rates are  
 1/10 Page--\$150/9mo, \$60/1mo; size=1.8 x 3.5 inch  
 1/4 Page--\$300/9mo, \$75/1mo; size=4.5 x 3.5 or 2.2 x 7.5 inch  
 1/3 Page- \$375/9mo, \$85/1mo; size=7.0 x 3.5 or 3.0 x 7.5 inch  
 1/2 Page--\$525/9mo, \$100/1mo; size=9.0 x 3.5 or 4.5 x 7.5 inch  
 Full Page--\$800/9mo, \$130/1mo; size=7.5 x 9.0 inch  
 1mo rate=(9mo rate/9)+\$40 (rounded up).

**VOTE: Al motioned to increase the advertizing rates by 25% (rounded to the nearest \$10) starting January 1, 2011. Dick 2<sup>nd</sup>; motion passed unanimously.**

- Bob Swenson sent E-mail requesting we send letter of support for modernization of the Geological materials center to the Governor's office. Dick will draft letter.
- Should we send letter of support for Bob Swenson? Al says that our new tax status does not preclude us from sending letters of support for political appointees

as long as we do not give financial support. But, we must fill out a **IRS Schedule C**.

We enjoyed working with him and support his continued service.” Dave 2<sup>nd</sup>; motion passed unanimously. Tom will draft letter.**
